October 2018; **Adjoint Deputy Public Prosecutor** at the Court of Salerno appointed by resolution of the CSM of September 19, 2018, entering into the aforementioned functions on October 22, 2018, until 30 June 2021; Deputy Public Prosecutor at the Court of Salerno appointed to the DDA since 1 July 2021 and Deputy Public Prosecutor at the Court of Salerno appointed to the Intersectional Group of Investigation on Terrorism since 29 September 2021.
