GIUSEPPE D'ANGELO (Ph.D.) is **Full Professor of Ecclesiastic and Canon Law** at the Department of Legal Sciences (School of Law) of the University of Salerno (Italy) where he teaches Ecclesiastical Law, Canon Law, Third Sector Law. At the same University, he has been a **Member of the Academic Board for the Ph.D. Program** in “International Law and Internal Law in the International Field: Public Ethics, Person, Stakeholders and Corporate Social Responsibility” (PESPECO), and is currently a Member of the Academic Board for the Ph.D. Program in “Legal Sciences”. He also teaches Ecclesiastical Law for the School of Specialization for Legal Professions. **He is qualified to practice law** in the Supreme Court and enrolled in the

Court’s special list of full-time university professors. He is **the scientific director of OPEROSTI** (Observatory on Religious Assets and Religious Bodies, Non-profit Organizations, Third Sector and Social Enterprise). His recent research is mainly focused on public law aspects of ecclesiastical law, canon law, religious law, and the relationship between religious law and public law. **He particularly focuses on the role of denominations and religious bodies in the transformation of welfare and the transition from the Welfare State to the Welfare Community** as well as the **implementation of the principle of subsidiarity and the principle of cooperation between the State and the Church**. More recently, his research activity has been directed toward the protection of religious freedom in a comparative perspective, the relationship between religious legal systems, national legal systems, and the EU’s legal system, and more widely, the principles and legal forms of the “public role” of religions in Western democracies, multicultural, and multi-religious societies.
