In particular, she's a member of the international research group concerning "Criminal law and the religious factor", at the Institute for Criminal Studies "Alimena" (ISPA), an interdepartmental research center of the University of Calabria. She is a member of the editorial board of "Stato, Chiese e pluralismo confessionale" (www.statoechiese.it) and member of editorial board of the third annual volume of the "Quaderni di Diritto e Politica Ecclesiastica" (Il Mulino, Bologna); member of the editorial board of "Jura & Legal Systems" and member of scientific board of "Milan Law Review" (www. riviste.unimi.it/index.php/milanlawreview). She is also a member of the scientific committee and managing editor of the series "DE - Series of studies and research in ecclesiastical law" (Edisud, Salerno).
