LUIGI KALB is Full Professor of Criminal Procedure Law at the Department of Legal Sciences (School of Law) of University of Salerno. From 1993 to 1998, he was a **Member of the Scientific Committee of the periodical “Annali dell’Istituto di diritto e procedura penale dell’Università degli Studi di Salerno”**, directed by Prof. Andrea Antonio Dalia; while from 1996 to 1998, he was also **coordinator member of its editorial board**. In 2000 he was a Member of the scientific committee of the Master’s degree course in “*Diritto processuale comparato per aspiranti avvocati penalisti europei*”. From 2005 to 2013, he was a **Member of the Executive Board at**

the School of Specialization for the Legal Professions of University of Salerno, being the Supervisor of the teaching programme of Criminal law procedure. From 2014 to 2017, he was **Supervisor of the PRIN research network about “Damages from criminal judicial activities”** and, from 2014 to 2018, **Member of the Board of Directors of the “Associazione tra gli Studiosi del processo penale G.D. Pisapia”**. In 2017, he was a Member of the Ministerial Commission established at the Italian Ministry of Justice-Legislative Office in Rome for the reform of the prison system (chaired by Prof. Glauco Giostra). From 2015 to 2021, Giuffrè Lefebvre published six editions of the Professor Kalb’s commented Criminal Procedure Code. He’s the **Scientific Director of the “G. Sabatini” multimedia laboratory** at the Department of Legal Sciences of the University of Salerno. Among others, he’s Co-Director of the book series “*Studi di diritto processuale penale*” (CEDAM), “*Strumenti di diritto processuale penale*” (Dike), “*Studi di diritto e procedura penale*” (Pacini) and “*Quaderni del laboratorio G. Sabatini*” (Wolters Kluwer). Since 2019, he has been a **Member of the Teaching Board of the Ph.D** at School of Law of University of Salerno, as well as Department **Head for General Public Law and Theory of Institutions**.
