FRANCESCO SCHIAFFO is Full Professor of Criminal Law, Professor of Criminology and Criminal Law at the Department of Legal Sciences of the University of Salerno. He's also Professor of Criminal Law at the School of Specialization for Legal Professions of the University "Federico II" of Naples. From 2002 to 2009, he was substitute teacher of criminology at the Faculty of Law of the University of Molise. He has been **scientific director of numerous research projects funded by the University of Salerno** and a member of the of numerous research groups, also funded by the same university. In similar fashion, he has **participated in the working groups of various national or international research projects**, among

which are noteworthy, in particular: the five-year inter-university project funded by the Italian National Research Center (C.N.R.) on "The Mobile Frontier of Penalties in Social Control Systems of the Second Half of the Twentieth Century" (1996-2000); the 2005 PRIN on "Criminal and Extra-Criminal Policies to Combat Organised Crime: An impact Assessment in the Perspective of European Harmonisation" (2006-2008); the 2007 PRIN on "The Reform of the Criminal Code in Italy. General Provisions" (2008-2010); the 2017 PRIN on "The Dark Side of the Law. When Discrimination, Exclusion and Oppression Are by Law" (ongoing). From 12 November 2012 to 11 March 2013 he **was guest of the Institut für die gesamten Strafrechtswissenschaften of the Ludwig Maximilian Universität München (BRD)** as part of a research project on "*Ontologismus und Normativismus in der Methodenlehre der Strafrechtswissenschaft*", admitted to funding by the University of Salerno in the international mobility program 2010. He's Scientific Coordinator of UNISA for the Agreement with the Permanent Global Mental Health Summit (bureau of Trieste).
