Inaugural Conference of EU-GLOBACT

The Jean Monnet Module '*Transnational crime and EU law: towards global action against cross-border Threats to common security, rule of law, and human rights*' (EU-GLOBACT) has convened its Inaugural Conference for 7 March 2024.

The title set for the Conference is '*Transnational Crime, Global Emergencies and Human Rights: The Judicial Cooperation for the Protection of Common Values of the European Union*' where distinct sessions will unfold in order to address the various perspectives and issues thereof.

Additionally, the EU-GLOBACT Inaugural Conference was selected by the French Embassy in Italy for a project concerning an International Symposium, an high-formation event to both gather and disseminate research outputs in order to further cooperation in the European region.

The event will take place at the premises of the University of Salerno (Italy) and will start the activities of the first edition of the Module. The Conference will be also broadcast online via Microsoft Teams and will be watchable by following a link that will be generated for that purpose.

Object

Specifically, the EU-GLOBACT Module aims to promote excellence in teaching and research in the field of EU legal studies, introducing a new focus on the emerging EU counter-crime policy, paramount to ensuring security and protecting European values, including the rule of law and fundamental rights, both in the EU and worldwide. In this perspective, the Module will contribute to spreading knowledge about the EU's priority to export European interests and values to the global stage through its active role and stronger voice in fighting terrorism and cross-border/online crimes.

EU-GLOBACT has Prof. Dr. Anna Oriolo as its Scientific Coordinator and boasts the didactic contribution of its Teaching Staff, comprising Prof. Dr. Andrea R. Castaldo, Prof. Dr. Angela Di Stasi, Prof. Dr. Michele Nino.

The main expected result of the Module is identifying solutions and best practices in fighting transnational offences that could be replicated at the European and international level.

Call for Papers: Focus Areas

To this end, the Module is launching an open Call for Papers for its Inaugural Conference. In particular, EU-GLOBACT encourages those interested to submit a paper in one topic of their choice from the list of focus areas below:

- Transnational crime, EU Law and global partnership;
- Transnational crime, EU Law and the Area of Freedom Security and Justice;
- Transnational crime, EU Law and new technologies;
- Transnational crime, EU Law and financial system.

While papers that engage these themes are especially welcome, proposals on other topics in the field of EU Legal Studies, will also be accepted.

Presentation at the Conference and Publication

A successful submission might result in presentation of the paper during the Inaugural Conference whether the author agrees to be present for the event, either at the set venue or online through the Microsoft Teams' platform. In the first instance, the author accepts to be photographed and filmed as well as to respect the time advocated to him and to be moderated by the corresponding Session Chair.

In any way, a successful submission will mean the publication of the paper within the Conference Proceedings volume, which is slated for release in August 2024.

Target of the Call

PhD and researchers, academic staff, lawyers, judicial operators, scholars, professionals, policymakers, NGOs, civil society representatives and experts.

Initial Submission Rules & Deadlines

Proposals can be individual or collective, provided that in the latter case a distinction regarding the authorship of the single parts of the paper is made.

Both the oral presentation of the papers (whether agreed by the author/s) and the subsequent publication may be made in English, French or Italian.

Those wishing to present a paper should send 2 (two) different documents:

- 1) Document containing
 - a. the title of the proposal;
 - b. indication of the focus area of choice (e.g., 'Transnational crime, EU Law and global partnership');
 - c. name and surname of the proposer;
 - d. university of origin, institutional affiliation or profession;
 - e. summary of the proposal (abstract) without the name of the proposer with a maximum length of 1,000 words.
- 2) Short curriculum vitae of the proposer (maximum 2-3 pages).

Submissions must be sent to info@euglobact.org at latest by 6 January 2024.

Evaluation of the Papers

The Scientific Committee will select proposals based on the relevance of the topic in relation to the subject of the Conference, consistency with the Module's focus areas, the quality of the approach developed and the originality of the proposal.

The Committee is composed of the Scientific Committee Coordinator, Prof. Dr. Anna Oriolo, and the Teaching and Research Staff of the Module.

Confirmation of Acceptance and Submission of the Full Paper

In case of successful submission, a confirmation of acceptance will be forwarded to the Proposer by the Module's staff via e-mail on 15 January 2024.

The selected Proposer must deliver a draft version of the paper before 7 March 2024 in order to allow the smooth running of the Inaugural Conference and the organisation of the work by the Session Chairs.

Later, the selected Proposer must deliver the final version of the paper at latest by 30 April 2024. The author(s) accepts to abide by the [Guidelines & Ethics](#) made available by EU-GLOBACT at the footer of

its official website. The selected Proposer shall write the final version of the paper according to the editorial criteria accordingly sent to him/her/them by the Module's Staff.
